AFFIDAVIT OF ATTEMPTED SERVICE

1. I am a process server, and as such have personal knowledge of the facts and matters hereinafter deposed to save and except those which are based on information and belief, and as to such matters I verily believe them to be true.

I was instructed by our client Kornfeld Mackoff Silber, Barristers & Solicitors of 1100 - 505 Burrard Street, Vancouver, BC, to serve MALCOLM CAMERON BOYD STEVENSON also known as MAC STEVENSON at the address of 29233 Duncan, Abbotsford, BC (hereinafter referred to as the "residence") and at the address of #9 - 32442 Dahlstrom, Abbotsford, BC (hereinafter referred to as the "alternate address"), with the WRIT OF SUMMONS AND STATEMENT OF CLAIM, a true copy of which is now produced and shown to me and marked as Exhibit "A" to this my Affidavit.

4. I attended at the residence on June 22nd, 2008 at 6:45 p.m., at which time there was no answer at the door after knocking for several minutes. The address numbers had been removed from the residence.


5. I attempted to attend at the alternate address on June 22nd, 2008 at 7:05 p.m., but I was unable to locate the address as it did not exist.


6. I attended at the residence on June 23rd, 2008 at 9:36 a.m, at which time there was no answer at the door after knocking for several minutes. There was a Hyundai SUV with a licence plate number 597 GBM parked in the driveway of the residence. There was a black Chevy pick up truck parked at the back of the residence, but I was unable to make out the licence plate number.

7. I attended at the residence on June 24th, 2008 at 4:36 p.m., at which time there was no answer at the door after knocking for several minutes. The Hyundai SUV was no longer parked in the driveway of the residence.

8. I believe that if the aforementioned documents were posted to the door of the residence at 29233 Duncan Avenue, Abbotsford, BC, they would be brought to the attention of MALCOLM CAMERON BOYD STEVENSON also known as MAC STEVENSON.
